AGREED ORDER FOR TELEMEDICINE/TELEHEALTH

Upon agreement of the parties, it is hereby ORDERED that DHHR is currently and will continue to reimburse at the current Medicaid rate all services provided by a licensed practitioner regardless of whether said service is provided onsite or through telemedicine/telehealth for all Medicaid recipients. In addition, DHHR will reimburse a facility fee for the originating or spoke site at which the member is located. Nothing herein will change the fact that DHHR will continue to only reimburse those services for which the recipient of the service is eligible and that all services will be provided in accordance with federal requirements.


